- 1. The provincial government adopt a model of full proportionate liability to replace joint and several liability
- 2. Implement enhancements to the existing limitation period including the continued applicability existing 10-day rule on slip and fall cases given recent judicial interpretation, and whether a 1- year limitation period may be beneficial
- 3. Implement a cap for economic loss awards
- 4. Increase the catastrophic impairment default benefit limit to \$2 million and increase the third-party liability coverage to \$2 million in government regulated automobile insurance plans
- 5. Assess and implement additional measurers which would support lower premiums or alternatives to the provisions of insurances services by other entitles such as non-profit insurance reciprocals
- Compel the insurance industry to supply all necessary financial evidence including
  premiums, claims and deductibles limit changes which support its, and municipal
  arguments as to the fiscal impact of joint and several liability.
- 7. Establish a provincial and municipal working group to consider the above and put forward recommendations to the Attorney General.
