- 1. THAT Royal Bank of Canada is appointed banker for the Customer.
- 2. THAT any one of Janet Gore, Clerk or Barbara Knauth, Deputy Clerk or Cheryl Swanson, Deputy Treasurer together with any one of Anne Commando- Dubé, Mayor or Nelson Costello, Deputy Mayor are authorized on behalf of the Customer from time to time:
 - (a) to withdraw or order transfer of funds from the Customer's Accounts by any means including the making, drawing, accepting, endorsing, or signing of cheques, promissory notes, bills of exchange, other orders for the payment of money or other instruments or giving of other instructions.
 - (b) to sign any agreements or other documents or instruments with or in favour of the Royal Bank, including agreements and contracts relating to products or services provided by Royal Bank to the Customer; and
 - (c) to do, or to authorize any person or persons to do, any one or more of the following: to receive from Royal Bank any cash or any securities, instruments, or other property of the Customer held by Royal Bank, whether for safekeeping or as security, or to give instructions to Royal Bank for the delivery or other transfer of any such cash, securities, instruments or other property to any person named in those instructions.
 - to deposit with or negotiate or transfer to the Royal Bank, for the credit of the Customer, cash or any security, instrument, or other property, and for those purposes to endorse (by rubber stamp or otherwise) the name of the Customer, or any other name under which the Customer carries on business, on any security or instrument.

 - to receive statements, instruments and other (including paid cheques) and documents relating to the Customers accounts with or any services of Royal Bank, and to settle and certify the Customer's accounts with Royal Bank.
- 3.  - in writing, any authorization made under the paragraph 2(c) of this Resolution.
- THAT any document furnished to Royal Bank as provided for in paragraph 4 of this Resolution shall be in binding upon the Customer until a new document repealing or replacing the previous one has been received and duly acknowledged in writing by the branch or agency of the Royal Bank where the customer has its account.
