**NOW THEREFORE** the Council of The Corporation of the Township of Matachewan **HEREBY ENACTS** AS FOLLOWS:


- 1. **THAT** the CAO, Clerk-Treasurer is authorized to sign the agreement with Citation Canada, attached hereto as Schedule "A".
