## BY-LAW No. 2024-51

## BEING A BY-LAW TO AMEND BY-LAW NO. 2023-15, A BY-LAW TO APPOINT AN EMERGENCY MANAGEMENT PROGRAM COMMITTEE.

WHEREAS Regulation 330/04 Part II sets Municipal Standards under the Emergency Management and Civil Protection Act R.S.O. 1990, Chapter E.9; and

## WHEREAS Section 11 states that:

- (1) Every municipality shall have an emergency management program committee. O. Reg. 380/04, s. 11 (1).
- (2) The committee shall be composed of,
  - (a) the municipality's emergency management program co-ordinator;
  - (b) a senior municipal official appointed by the council;
  - (c) such members of the council, as may be appointed by the council;
  - (d) such municipal employees who are responsible for emergency management functions, as may be appointed by the council; and
  - (e) such other persons as may be appointed by the council. O. Reg. 380/04, s. 11 (2).
- (3) The persons appointed under clause (2) (e) may only be,
  - (a) officials or employees of any level of government who are involved in emergency management:
  - (b) representatives of organizations outside government who are involved in emergency management; or
  - (c) persons representing industries that may be involved in emergency management. O. Reg. 380/04, s. 11 (3).
- (4) The council shall appoint one of the members of the committee to be the chair of the committee. O. Reg. 380/04, s. 11 (4).
- (5) The committee shall advise the council on the development and implementation of the municipality's emergency management program. O. Reg. 380/04, s. 11 (5), and
- (6) The committee shall conduct an annual review of the municipality's emergency management program and shall make recommendations to the council for its revision if necessary. O. Reg. 380/04, s. 11 (6).

**WHEREAS** Council deems it necessary to appoint an Emergency Management Program Committee for the municipality;

**AND WHEREAS** on the 27<sup>th</sup> day of August, 2024 the Council appointed Michael Young as Mayor, effective August 28<sup>th</sup>, 2024;

**NOW THEREFORE** we, the Council of the Corporation of the Township of Matachewan, **HEREBY ENACTS AS FOLLOWS:** 

- 1. THAT Michael Young, Kim Gauthier, Cheryl Drummond, Cheryl Swanson, Mike Schoenwald and Lynn Aubé be appointed to the Emergency Management Program Committee for the Corporation of the Township of Matachewan.
- 2. THAT this By-law shall come into force on September 19, 2024.
- 3. THAT all other by-laws or resolutions, or parts thereof, contrary hereto or inconsistent herewith, be and the same are hereby repealed.
